



## Twin Valley School District 2020-21 Superintendent / Assistant Superintendent Goals

### Domain 1: Student Outcomes

**Vision:** We believe that meeting all students' needs through appropriately challenging them and providing purpose through relevant and rigorous opportunities in and outside of school will allow each student to reach his/her own personal potential.

**Theory of Action:** If we develop a collaborative culture of high expectations, high levels of support and collective accountability then we will improve student outcomes including performance on standardized assessments.

#### **Action Items:**

1. Instructional Leadership: Develop and implement an instructional coaching model with Principals as instructional leaders.
2. Data-informed instructional practice: Expand data dashboard to include locally developed common assessments to drive building level data team meetings and improve teaching and learning.
3. Curricular Programming: Improve student outcomes by improving curricular programming.
  - a. Exact Path - Implement Exact Path at grades 3-8 in both ELA and math.
  - b. Text Dependent Analysis - create multiple performance tasks to teach and measure students analysis

3. Develop and implement surveys to assess shareholder feedback (students, staff, and parents) on culture, climate, and student outcomes. Information will be shared with TVEA leadership.
4. Expand communication with staff to include quarterly meetings with TVEA building reps

## **Domain 3: Safety and Advocacy**

**Vision:** We believe that providing a safe and nurturing learning environment is necessary for celebrating diversity, creating a shared sense of community, and focusing on the importance of the whole child.

**Theory of Action:** If we maintain vigilance in conducting safety walkthroughs, formal site assessments and drills with staff and students, then we continue to provide the safest possible environment for our staff and students.

### **Action Items:**

1. School Reopening Plan: Develop and implement TVSD Health & Safety Plan for School Reopening and present for Board approval.
2. Site Assessment: In coordination with BCIU Safety Officer, conduct formal site assessment of REC.
3. Increase mental health support at all buildings.
4. Implement Infinite Campus Multi-Tiered Support Services (MTSS) tracking system to identify students in need of academic, behavioral, and social-emotional support and document interventions in a systematic way.

2. TVMS One Schedule: Complete implementation of TVMS One Schedule
3. K-12 1-to-1 Initiative: Implement 1-to1 device program including iPads at Kindergarten and Chromebooks 1-2. Implement SeeSaw learning management system (LMS) for in-person and online learning.
4. Twin Valley Virtual Academy (TVVA): Continue to improve and market TVVA to meet the needs of TVSD students seeking online programming.
